6. Camping is available and encouraged for performers. Please check with the festival producer for more information.
7. NO PETS are allowed on festival grounds without prior written approval from festival management.
8. Participants consent to the use of their names, pictures, images, recorded voice or music in connection with festival events and without inspection for such purposes and commercial or promotional use.
9. All artist/group members agree to comply with festival, Federal, State, County, and local ordinances and/or regulations.
10. All members agree to defend, indemnify, and hold harmless Empire Events (festival production company), Nevada City Community Broadcast Group, Inc.
